## Spotlight on our Researchers:

### Dr. Rochelle L. Dalla

Rochelle L. Dalla, PhD, CFLE (Certified Family Life Educator), is Professor of Family Studies in the Department of Child, Youth and Family Studies at the University of Nebraska-Lincoln. For the past twenty-five years, her research has focused on marginalized and hard-to-reach populations. This work began on the Navajo Native American reservation, where she studied life-course trajectories and inter-generational family dynamics of adolescent mothers. Her current research -



focused on sex trafficking survivors - began in 1998 with research attention to the developmental trajectories, family relational dynamics, and psycho-social well-being of street-level prostituted women. Dr. Dalla's research interests have expanded to include human trafficking in India. In the urban environment of Mumbai, she focuses on the developmental trajectories and well-being of sex trafficking survivors and their children who reside in the urban red-light brothel districts. Her research provides knowledge and information about little-understood populations, elevates the voices of marginalized women across the globe, is impactful locally, nationally, and internationally, and articulates critical avenues for continued research and scholarship. Dr. Dalla leads the Human Trafficking and Vulnerable Population Research Lab at UNL, serves as Editor-in-Chief of the Journal of Human Trafficking and is co-editor of the recently released Routledge International Handbook of Human Trafficking: A Multi-disciplinary and Applied Approach. As a professor at UNL, Dr. Dalla teaches a variety of graduate and undergraduate courses. She has been honored with multiple research and teaching awards, including the Distinguished Research and Creative Career Award (2018), Distinguished Teaching Award (2017 and 2001), Swanson Award for Teaching Excellence (2007), and the Charman Outstanding Professor Award (2004).

### Dr. Donna Sabella

Donna Sabella, M.Ed, MSN, PhD, RN, PMHNP-BC, began work in the anti-human trafficking field while serving as a mobile psychiatric nurse specialist in Philadelphia where she worked with women who were being prostituted. Wanting to provide them with services, yet realizing there were none in Philadelphia, she searched for people and programs across the U.S. who could help her do so. She spent time in DIGNITY, the program Kathleen Mitchell started in Phoenix, Arizona. Returning



to Philadelphia, she connected with others to create Dawn's Place, the first residential treatment program in Philadelphia for trafficked and prostituted women, where served as their first Program Director. She provided counseling to female inmates in the Philadelphia Prison System charged with prostitution in both her Project Phoenix program as well as through Project Dawn, the Philadelphia Diversion Court. Her research has involved exploring the lived experience of trafficked and prostituted women. She is the former Seedworks Endowed Associate Professor of Social Justice at UMass Amherst and has taught numerous courses on human trafficking, including developing a certificate in human trafficking while at Drexel University. She is a psychiatric nurse practitioner and Professor at PA College of Health Sciences where she directs their graduate Psych NP program. She is a co-founder and an Associate Editor of the Journal of Human Trafficking and is the co-editor of the Routledge International Handbook of Human Trafficking: A Multi-Disciplinary and Applied Approach.
